Missing Document(s)	Type of document
	Cover letter completely filled on https://applyvisa.um.dk/ , printed and signed by the applicant.
	Visa Fee payment receipt printed from https://applyvisa.um.dk/
	The Original passport should be valid for at least 3 months beyond the intended duration of stay in the Schengen territory and with at least two blank page to affix the visa. The passport must have been issued within the last 10 years.
	Copy of previous visas and stamps of the applicant's old passport(s) <i>if any</i> .
	Copy of name or surname change certificate , if applicable.
	Proof of occupation. Original documents confirming employment, private business(business/commercial registration), school or studies and permission for leave.
	An itinerary of the planned trip if several countries are visited -if travelling in an organised trip: a certificate or voucher (original) from a travel agency or tour operator confirming the booking of an organised tour
	Confirmation of accommodation in Denmark (and other Schengen countries, if the applicant is going to other countries on the same trip)
	Documentation of funds to cover the trip. <i>According to the Danish Immigration Service you must have the necessary means to pay for your stay and return trip. As a general rule, you must have at your disposal approx. DKK 350 per day. If you are staying in a private home. If you are staying at a hotel, the amount must be greater, approx. DKK 500 per day. You can find further information https://www.nyidanmark.dk/</i>
	Round trip ticket. Flight/train/ferry reservation with fixed travel dates of maximum 90 days to Denmark and other Schengen countries. (Do not buy the ticket until a visa has been granted).
	Overseas travel medical insurance valid for all Schengen-countries. The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure.
	<u>If the applicant is under 18, he/she must also submit:</u> Copy of birth certificate (bring <u>original</u> for verification) <i>If you are travelling alone:</i> <input type="checkbox"/> An original letter of consent signed by both parents, stamped by Amphur. <i>If you are travelling with only one of your parents:</i> <input type="checkbox"/> An original letter of consent from the other parent, stamped by Amphur. <i>If the parent you are travelling with has single custody:</i> <input type="checkbox"/> A copy of certificate of single custody (bring <u>original</u> for verification).

Note : A translation to English/Danish must be attached to any documents in Thai
